



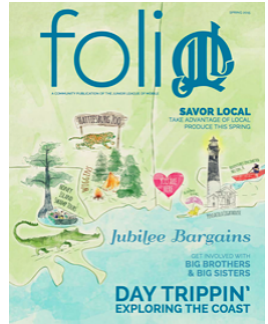

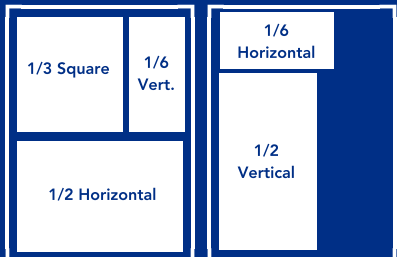
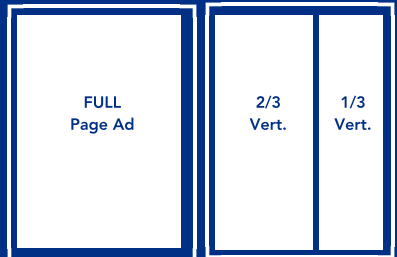

Page trim size is 8.5" x 11"

All live copy should be 1/4" away from trim dimensions on all sides. No safety necessary for live matter in gutter on spread bleed ads. Maximum density for four-color process is 300%.

Output from disk: folio is produced using Adobe InDesign C85 for Mac. Files for ads can be accepted in the following formats:

- High-resolution PDF file (preferred)
- High-resolution image file (tiff or jpeg)
- Other formats, such as Microsoft Publisher, PowerPoint or Word, will require rebuilding of the ad. Fees are based on ad layout charges as noted above.
